PART B: MATERIALS AND WORKS

Part B sets out details about placing Orders. It also sets out the process that applies if there are any issues with an Order or if an Order is cancelled.

- Order process You may order Materials and Works from us in accordance with our order processes that we advise to you at any time. All Orders are subject to acceptance by us. We may accept an Order (in whole or in part) by issuing an invoice for the applicable Materials and Works, delivering the Materials and Works or otherwise confirming the order in writing. We are under no obligation to enquire as to the authority of any person placing an Order on your back 22

These variations will be submitted to you for approval, and you shall be required to respond to any variation submitted by us within 10 Business Days. Failure to do so will entitle us to add the cost of the variation to the Order. Payment for all variations must be made in full at the time of their completion. 2.5

PART D: PAYMENT TERMS

Under these Terms, we may supply Materials and Works to you on credit. It is very important to us that you pay us in full by the due date for payment. The following clauses provide additional protections for us to reflect that arrangement, including terms that will apply if there are any delays or disputes relating to payments
